

Terms and Conditions

When you use our website and services, you will be able to book therapy/counselling sessions via www.arunatherapy.com and make digital purchases. When you do so we will monitor and review the content submitted or created using our services to you. We reserve the right to access, copy, distribute, store, reformat and display the content of the information you provide to us solely for the purpose of providing the services to you. If you provide any information that is untrue, inaccurate, not current, incomplete, or violates any of our policies or is in any way harmful we have the right to suspend or terminate your account and refuse any and all current or future use of the site.

By using our services, you are responsible for:

- All your registered information must be true, accurate, current and complete.
- You will ensure you maintain the accuracy of your information and update this when necessary.
- You must be at least 18 years of age to use our website and services.

Billing and payments

You confirm and agree to use only credit cards or other payment means (collectively "Payment Means") which you are duly and fully authorized to use, and that all payment related information that you provided and will provide in the future, for Therapy sessions or shop purchases, is accurate, current, and correct and will continue to be accurate, current, and correct.

You agree to pay all fees and charges associated with your session bookings and product purchases on a timely basis and according to the fees schedule, the terms and the rates as published on www.arunatherapy.com. By providing us with your Payment Means you authorize us to bill and charge you through that Payment Means and you agree to maintain valid Payment Means information in your Account information.

We do not offer refunds for our digital products or services. However, if you are in any way dissatisfied with one of our products or service, please do contact us on the email address below and we will try our best to resolve any issues or concerns you may have.

Cancellations

Please note that once you have booked a counselling and therapy session with us it means we have reserved time in our schedule exclusively for you. If you miss a booking with no prior notice, you will be charged the full-service fee. If you wish to cancel or change your booking, please do so at least 24 hours prior to your booking. Any cancellations made less than 24 hours before your booking, will be subject to a late cancellation charge of 50% of the full-service fee.

Security
